Introduction:

The **19th National Jamboree of Bharat Scouts and Guides** will host approximately **30,000 participants** from across India and abroad. To provide them a unique experience of adventure, discipline, and teamwork, the **Adventure Base** will be one of the most significant activity zones of the Jamboree.

The State Headquarters, Bharat Scouts and Guides, Uttar Pradesh, invites bids from reputed and experienced **Adventure Base Setup Firms/Agencies** to design, install, operate, and maintain safe adventure activities during the Jamboree.

Scope of Work:

The selected firm/agency shall be responsible for the following:

- **Design, Fabrication, and Installation**
 - Setting up of all approved **Adventure Bases/Activities** as per specifications.
 - Construction of necessary towers, bridges, climbing walls, and adventure structures using certified materials (Steel/Iron – TATA / APOLLO / Any ISI-marked primary steel can be used – Approved Quality).
 - Ensuring all installations meet safety and engineering standards.
 - STEEL IRON PIPE (TATA / APOLLO / Any ISI-marked primary steel can be used) – Vertical Member C Type MS Pipe & other Structural member B Type MS Pipe, Painted with Epoxy Based Primer and Paint. Color shades Approved by BSGUP.
- All material shall be used accordance with U.P. Government Order B.I.S. Code No. 01/2023/I/263552 dated 12.01.2023 (photocopy enclosed) or Approved by BSGUP.
- **Operation and Management during Jamboree**
 - Facilitating adventure activities for approximately **30,000 participants** during the Jamboree period (23rd to 29th November, 2025).
 - Providing trained and certified **Adventure Instructors, Safety Supervisors, and Technical Staff** to conduct activities.
 - Daily inspection, repair, and maintenance of all adventure bases and equipment.
 - Maintaining logbooks of activity usage, participant safety, and daily inspection reports.
- **Safety and Security Arrangements**
 - Installation of **safety harnesses, helmets, ropes, carabiners, pulleys, and rescue equipment** at each base.
- **Fun and Recreational Activities**
 - Setup and operation of all ground level Adventure/Activates.
 - Ensuring safe operation with supervision at each activity.



- **Maintenance, Dismantling & Re-Installation**

- Regular preventive maintenance of all installations during the Jamboree.
- Dismantling of all bases after completion of the event.
- Shifting and re-installation of all Steel/Iron Adventure and all fun bases and all equipment at a designated location in Prayagraj, as directed by BSGUP.
- Restoring the Jamboree Ground to its original condition post-event.

- **Manpower and Training**

- Deployment of sufficient technical manpower including **fabricators, belayers, adventure experts, and helpers.**
- Orientation and training sessions for volunteers and staff assisting in activities.

- **Documentation & Compliance**

- Daily reporting to the BSGUP Jamboree Committee regarding activities conducted and safety audits.
- Compliance with all legal, statutory, and insurance requirements.

- **Insurance & Liability**

- Comprehensive insurance coverage for all adventure equipment.
- Full responsibility for safety of all operations, relieving the BSGUP of any liability.



ELIGIBILITY CRITERIA FOR SUBMITTING TECHNICAL BID:

Bidders must carefully read the following **Conditions of Eligibility**. Proposals of only those Bidders who satisfy these conditions will be considered for opening of the Financial Bid.

Instructions to the bidder (ITB):

1. The information and instructions for bidders posted on the website www.bsgup.org shall form part of the bid document.
2. The bidders are advised to **physically visit the site** of the proposed Jamboree, prior to commencement of the bidding process, for better understanding of the entire concept. The layout of the site is enclosed herewith.
3. The prospective bidder must **read the terms and conditions** of the bidding document carefully and must submit the bid only upon fulfilment of eligibility criteria and possession of all valid documents.
4. All the information/ corrigendum/ addendum related to the project shall be published on the website: www.bsgup.org. The BSGUP shall have the right to reject the bid partially or fully without assigning any reason whatsoever. The decision of the BSGUP shall be final and binding.
5. The bid document consisting of specifications, the schedule of tentative quantities of various items to be executed, the scope of work, and the set of terms and conditions of the bidder can be seen and downloaded from the website: www.bsgup.org.
6. **Earnest Money Deposit (EMD)** should be paid by Demand Draft (in original) in favour of **State Secretary, U.P. Bharat Scout and Guide** along with the hard copy submission, failing which the bid shall be liable to rejection.
7. The bids are to be submitted only in **physical mode**, in original, and must be unconditional.
8. **Joint Venture/ Consortium/ Association of Bidders** and the process of Alternate Bids are **MAY BE ALLOWED**.
9. The language of the bid documents shall be **ENGLISH**.
10. The Bid Evaluation Criteria (Selection Method) as per Potential Assessment Bid, shall be **Financially overall L1 (lowest)**.
11. An **Affidavit** (Stamp Paper of Rs.100/- denomination) must be submitted affirming non-registration of any criminal case against the bidder or its firm and confirming that the firm has not been blacklisted by Government or Semi-Government agencies (as per **Annexure-2**).
12. **Additional Security** will be payable according to **G.O. No. 622/23-12-2012-2 Audit/08 T.C.-2 dated 08.06.2012**, for unbalanced bids.
13. The bidder shall submit **Performance Security @ 5%** of the total bid value in the form of a Demand Draft or Bank Guarantee in favour of **State Secretary, U.P. Bharat Scout and Guide**.
14. All rates are inclusive of **Bidder's Profit, Tools & Plants (T&P), and all taxes** etc., except GST. The GST shall be payable as per the latest rules. The bidder must be registered for GST.
15. **Sub-contracting will not be allowed.**
16. The **safety and security** of the personnel or team members of the bidder, including insurance, shall be the responsibility of the bidder.



17. The BSGUP shall have the authority to **relax any bidding condition** in the interest of the Jamboree.

INSTRUCTIONS TO BIDDER FOR TENDERING PROCESS:

- The bidding process for this tender will be completed through submission in **physical mode only**.
- The tender document can be downloaded free of cost from the Website: www.bsgup.org.
- The bidders must submit (in physical mode only) all the required documents (technical proposal) along with the **Financial Proposal Submission Form (BOQ)** in the prescribed format.
- The **Cost of Tender Document** and the **EMD** must be submitted through **Demand Draft only**, drawn in favour of **State Secretary, U.P. Bharat Scout and Guide**
- The bidding process comprises a **two-envelope system**:
 - (i) Technical Bid (with all eligibility and supporting documents)
 - (ii) Financial Bid (BOQ)
- Both envelopes shall clearly bear the label **“APPLICATION FOR QUALIFICATION FOR ADVENTURE BASE SETUP FIRM/AGENCY”**.
- The two envelopes shall be placed inside **one sealed main envelope** and submitted at the address below:

- If the envelopes are not sealed and marked as instructed above, BSGUP assumes no responsibility for misplacement or premature opening of the application.
- Applications submitted by **e-mail** shall not be entertained and shall be **rejected**.

Selection of Bidder:

- a) The financial bid of only those bidders shall be opened who qualify the minimum eligibility criteria as given at Sl. No. 19. At the discretion of the BSGUP, the financial bid may also be opened in case of a single technically qualified bidder.
- b) The proposal with the **lowest financial quote (L1 Bidder)** shall be declared successful and selected.
- c) In the event of a tie between two or more bidders (i.e., equal financial quotes), the bidder shall be selected on the basis of **negotiation** in terms of the financial bid.
- d) **Negotiation:** BSGUP reserves the right to call or negotiate with the L-1 bidder, if required.
- e) **Advance Payment:** An advance payment of up to ₹5,00,000 (Rupees Five Lakhs only) may be released upon submission of a Bank Guarantee/Fixed Deposit (FD) pledged in favor of the State Secretary, UP Bharat Scout and Guide.



f) **Running Payment:** Payments may be released from time to time, proportionate to the progress of the Adventure Bases.

g) The bid submitted shall become **invalid** in the following cases:

- (i) The bidder does not submit all the required documents (including GST registration) as stipulated in the bid document.
- (ii) If a bidder quotes **NIL rates** against each item in the 'Item Rate Tender' or does not quote any percentage above/below the total amount of the tender.
- (iii) If the bid documents are **incomplete or not duly filled**.
