विज्ञप्ति

सर्वसाधारण को सूचित किया जाता है कि कर्मचारी राज्य बीमा योजना, श्रम चिकित्सा सेवाएं, उ0प्र0 के अन्तर्गत चिकित्साधिकारी, (एलोपैथ) के 256 पद (जिसमें उ0प्र0 के अन्य पिछड़ा वर्ग के अभ्यर्थियों हेतु-48 पद, उ0प्र0 के अनु0 जाति के अभ्यर्थियों हेतु-55 पद, उ0प्र0 के अनु0 जनजाति के अभ्यर्थियों हेतु-07 पद, उ0प्र0 के (EWS) आर्थिक रूप से कमजोर वर्गों के अभ्यर्थियों हेतु-19 पद, अनारक्षित-127 पद, तथा क्षैतिज आरक्षण के तहत 51 पद महिलाओं हेतु व दिव्यांग (OA/OL) अभ्यर्थियों हेतु-10 पद आरक्षित हैं।) पर सीधी भर्ती के माध्यम से चयन हेतु आयोग के विज्ञापन संख्या-01/2020-21, विभाग संख्या-सेवा-9/02, दिनांक-05.09.2020 तथा विज्ञप्ति-दिनांक 15 दिसम्बर, 2021 को जारी किया गया था। उक्त विज्ञापन के सापेक्ष दोनों चरणों में कुल 2970 अभ्यर्थियों द्वारा ऑनलाइन आवेदन किया गया था। प्रश्नगत पद का साक्षात्कार दिनांक-08, 09, 14, 15, 16, 20, 21, 22, 23, 24 व 25 जून, 2022 को सम्पन्न हुआ। साक्षात्कार हेतु आहूत अर्ह अभ्यर्थियों की संख्या-965 थी, जिसमें कुल 593 अभ्यर्थी उपस्थित हुए। प्रश्नगत चयन में कुल 256 रिक्तियों के सापेक्ष 256 अभ्यर्थियों को अन्तिम रूप से सफल घोषित किया गया है। चयन परिणाम आयोग की वेबसाइट <https://uppsc.up.nic.in> पर उपलब्ध है।
