I. Introduction

Bharat Scouts and Guides, Uttar Pradesh is organizing the **19th National Jamboree** from 23rd to 29th November, 2025, and invites tenders from experienced photography and videography agencies to cover the entire event. The selected agency must provide high-quality professional services as per the event requirements. The agency will be responsible for capturing high-resolution still images and video content, along with on-site editing, to produce prompt deliverables suitable for event documentation, social media promotion, and online streaming.

I. Scope of Work:

The selected agency will be responsible for **complete coverage** of the 19th National Jamboree through:

- Professional photography, videography and Drone.
- Crane coverage (camera jib/crane for wide shots)
- Live streaming of major events (opening, closing, cultural programs, speeches)
- Pre-Jamboree events (may be at different places aloso).

Activities to be covered:

- Opening and closing ceremonies
- Parade, adventure, and cultural activities
- Dignitary visits, exhibitions, stage performances
- Workshops, camps, food zones, and daily life at the venue
- Group photographs (scouts, guides, officials)

2. Deliverables:

- Minimum 5,000 high-resolution edited photographs
- Event teaser (2 mins) and highlight video (10–15 mins)
- Daily recap videos (2–3 minutes each) Reel and Video
- Live streaming (YouTube/Facebook) setup and execution
- Crane shots of main stage and public gathering areas
- Full coverage of opening and closing ceremonies (multi-cam)
- Hard drive submission of all raw + edited data every Day.
- High-quality hardbound album- Photo Album consisting of 100 pages, Matt finish, minimum 150GSM Paper with Acrylic Album cover.
- Any other thing as per requirement of BSGUP Committee.

Submission timeline: Within 60 days post-event.

3. Minimum Technical Requirements:

- Minimum 6 DSLR/Mirror less cameras (full-frame) Gimbals/Handhandle
- 4 professional 4K video cameras with tripods
- 2 Zip Crane setup (minimum 18 ft) for dynamic stage/audience shots
- 2 drone (4K) with licensed operator (subject to permissions)
- Audio capture kit: wireless mics/lapel + sound mixer
- Live streaming setup: switcher, encoder, broadband/Wi-Fi dongles
- Power backup, LED lights, multi-cam coverage gear
- Minimum 15 technical staff: photographers, videographers, editor, zip crane operator, drone pilot, streaming expert.

4. Eligibility Criteria:

- Minimum 5 years experience in event photography/videography/live streaming
- Completed 3+ similar govt./public events in past 5 years
- Experience of **live streaming on platforms** like YouTube/Facebook
- Must provide **sample videos** and photo albums of past events (Soft copy)
- Registered firm with valid GST & PAN
- Compliance Statement and Declaration must be attached

5. Additional Terms & Conditions:

- Agency must take all permissions/License for drone and live streaming & Other as Required.
- All content to be used only with prior written consent of BSG.
- Daily content preview may be requested by BSG committee
- Penalty of ₹1,000/day for delayed submission
- Organizers will provide basic facilities such as access passes, electricity, stage access, and required storage space.

Instructions:

- The information and instructions for bidders posted on the website <u>www.bsgup.org</u> shall form part of the bid document;
- 2. The bidders are advised to physically visit the site of the proposed Jamboree, prior to commencement of bidding process for better understanding of the entire concept. The Layout of the site is enclosed herewith;
- 3. The prospective bidder must read the terms and conditions of bidding document carefully and must submit the bid only upon fulfilment of eligibility criteria and being in possession of all valid documents;
- 4. All the information/ corrigendum/ addendum related to the project shall be published on the website: www.bsgup.org. The BSGUP shall have the right to reject the bid partially or fully without assigning any reason whatsoever. The decision of the BSGUP shall be final and binding;
- 5. The bid document consisting of specifications, the schedule of tentative quantities of various items to be executed and the set of terms and conditions of the bidder to be complied with and other necessary documents can be seen and downloaded from the website: www.bsgup.org;
- 6. Earnest Money should be paid by Demand Draft (in original) in favour of State Secretary, Uttar Pradesh Bharat Scout and Guide, Lucknow, along with a hard copy at the website: www.bsgup.org, failing which, the bid shall be liable to be rejected;
- 7. The bids are to be submitted only in physical mode, in original, and the type of bids shall be unconditional:
- 8. Joint Venture/ Consortium/ Association of Bidders and the process of Alternate Bids is NOT ALLOWED;
- 9. The language of the bid documents shall be in ENGLISH;
- 10. The Bid Evaluation Criteria (Selection Method) as per Potential Assessment Bid, shall be Financially overall L1 (lowest);
- 11. An Affidavit (Stamp Paper of Rs.100/- denomination) needs to be submitted affirming about non registration of any criminal case against the bidder or its bidding firm and not having been Black Listed by Government or Semi- Government agency. (as per Annexure-1).
- 12. The bidder shall submit performance security @ 5% of the total bid value in the form of either a Demand Draft or a Bank Guarantee in favour of State Secretary, BSGUP.
- 13. All rates are inclusive of Bidder's Profit, T&P and all taxes etc. except GST. The GST shall be payable as per latest rules. The bidder must have registered for GST purposes.
- 14. Sub-contracting will not be allowed.
- 15. The safety and security of the personnel or the members of the team of the Bidder and their insurance shall be the responsibility of the bidder;
- 16. The BSGUP shall have the authority to relax any bidding condition in the interest of the Jamboree

INSTRUCTIONS TO BIDDER FOR TENDERING PROCESS:

The bidding process for this tender will be completed through Tender in physical mode. The tender document can be downloaded free of cost from the Website: www.bsgup.org.

The Bidders must submit (in physical mode only) all the required documents (which would form the technical proposal) along with the Financial Proposal Submission Form in the prescribed format.

The cost of tender document and the EMD has to be submitted through Demand Draft only drawn in favour of State Secretary, Uttar Pradesh Bharat Scout and Guide, Lucknow.

The bidding process comprises of two envelope system. The technical and the financial bid shall be kept in two separate envelopes and shall clearly bear the Technical Bid or the Financial Bid. Each envelope shall also bear "APPLICATION FOR QUALIFICATION FOR PHOTOGRAPHY AND VIDEOGRAPHY FIRM/AGENCY". Both envelopes shall be kept in one big envelope containing Technical and Financial bids and this envelope shall be submitted at the address given herein below.

- b) The proposal with the lowest financial quote shall be declared L1 Bidder and shall be selected.
- c) In case of a tie between two or more bidders (i.e., equal quote in financial bid), the bidder will be selected on the basis of negotiation in terms of financial bid.
- d) Negotiation

BSGUP shall have right to call or to negotiate with L-1, if required.

- e) The selected L-I will be required to enter into a contract agreement with the BSGUP to provide the envisaged services described in the BoQ.
- f) The bid submitted shall become invalid in the following cases:
 - (i) The bidder does not submit all the documents (including GST registration) as stipulated in the bid document
