2. The bidders are advised to physically visit the site of the proposed 19<sup>th</sup> National Jamboree of Bharat Scout and Guide at Defence Expo Ground, Sector-15, Vrindavan Awas Vikas Parishad, Lucknow, Uttar Pradesh, prior to commencement of bidding process for better understanding of the entire concept. The Layout of the site is enclosed herewith;

3. The prospective bidder must read the terms and conditions of bidding document carefully and must submit the bid only upon fulfilment of eligibility criteria and being in possession of all valid documents;
4. All the information/ corrigendum/ addendum related to the project shall be published on the website: [www.bsgup.org](http://www.bsgup.org). The BSGUP shall have the right to reject the bid partially or fully without assigning any reason whatsoever. The decision of the BSGUP shall be final and binding;
5. The bid document consisting of specifications, the schedule of tentative quantities of various items to be executed and the set of terms and conditions of the bidder to be complied with and other necessary documents can be seen and downloaded from the website: [www.bsgup.org](http://www.bsgup.org);
6. Earnest Money should be paid by Demand Draft (in original) in favour of Secretary, Bharat Scout and Guide, Uttar Pradesh, Lucknow, alongwith a hard copy at the website: [www.bsgup.org](http://www.bsgup.org), failing which, the bid shall be liable to be rejected;
7. The bids are to be submitted only in physical mode, in original, and the type of bids shall be unconditional;
8. Joint Venture/ Consortium/ Association of Bidders and the process of Alternate Bids is NOT ALLOWED;
9. The language of the bid documents shall be in ENGLISH;
10. The Bid Evaluation Criteria (Selection Method) as per Potential Assessment Bid, shall be Financially overall L1 (lowest);
11. An Affidavit (Stamp Paper of Rs.100/- denomination) needs to be submitted affirming about non registration of any criminal case against the bidder or its bidding firm and not having been Black Listed by Government or Semi-Government agency;
12. Additional Security will be payable according to G.O. No.622/23-12-2012-2 Audit/08 T.C.-2 Dated 08.06.2012, for unbalanced bids;
13. The qualified bidder shall have to register all the labourers employed in the project with the Department of Labour, as per extant rules;
14. The bidder shall submit performance security @ 5% of the total bid value in the form of either a Demand Draft or a Bank Guarantee in favour of in favour of Secretary, BSGUP;
15. All rates are inclusive of Bidder's Profit, T&P and all taxes etc except GST. The GST shall be payable as per latest rules. The bidder must have registered for GST purposes.
16. Ordinarily sub-contracting will not be allowed, however, under exceptional circumstances, contracting to the extent of 25% of the total bid value may be allowed only with the prior written approval of BSGUP;
17. The safety and security of the personnel or the members of the team of the Bidder and their insurance shall be the responsibility of the bidder;
18. The BSGUP shall have the authority to relax any bidding condition in the interest of the Jamboree, 2025.

19. **INSTRUCTIONS TO BIDDER FOR TENDERING PROCESS**

The bidding process for this tender will be completed through Tender in physical mode. The tender document can be downloaded free of cost from the Website: [www.bsgup.org](http://www.bsgup.org).

The Bidders must submit (in physical mode only) all the required documents (which would form the technical proposal) alongwith the Financial Proposal Submission Form (BOQ) in the prescribed MS-Excel (XLS) format.

The cost of tender document and the EMD has to be submitted through Demand Draft only drawn in favour of State Secretary, Uttar Pradesh Bharat Scout and Guide, Lucknow.

The presentation has to be submitted as a part of the technical proposal in physical mode. The presentation can be submitted as a hard copy in a separate envelop on or before the Bid upload date/ time of Technical & Financial Bid submission at the address given below.

The bidding process comprises of two envelope system. The technical and the financial bid shall be kept in two separate envelopes and shall clearly bear the Technical Bid or the Financial Bid. ## 22. Selection of Bidder

- a) The bidders are required to score minimum 70 points out of 100 in Technical Bid (technical marks and presentation marks) to qualify for opening of financial proposal. Based on the technical assessment, which includes presentation, the financial bids of only the selected bidders who score the minimum threshold marks in technical qualification will be opened, in the presence of authorized representatives of the bidder, if interested;
- b) The financial bid of only those bidders who are shortlisted after technical evaluation will be opened for financial evaluation on the notified date and time as given on the website [www.bsgup.org](http://www.bsgup.org). At the discretion of the BSGUP management, financial bid may be opened in case of single technical bidder also;
- c) The proposal with the lowest financial quote shall be declared L1 Bidder;
- d) In case of a tie between two or more bidders (i.e., equal quote in financial bid), the bidder with higher score under technical evaluation shall be ranked first in order;
- e) Negotiation  
BSGUP shall have right to call or to negotiate with L-1, if required. The Payment terms shall be negotiable.
- f) The selected L-1 will be required to enter into a contract agreement with the BSGUP to provide the envisaged services described in the BoQ.
- g) The bid submitted shall become invalid in the following cases:
  - (i) The bidder does not submit all the documents (including GST registration) as stipulated in the bid document
  - (ii) If a bidder quotes NIL rates against each item in 'Item Rate Tender' or does not quote any percentage about/ below on the total amount of the tender
  - (iii) If any required form attached with this bid is not duly filled.
- h) **Item rate tenders**

Only rates quoted shall be considered for instant tender process due to Item Rate Tender. Any tender containing percentage below/ above the rates quoted is liable to be rejected. Rates quoted by the bidder in item rate tender in figures and words shall be accurately filled in so that there is no discrepancy in the rates written in figures and words. All rates will be excluding GST. IN case of any discrepancy, the rate quote in words shall be taken into consideration.

## 23. **Bid Capacity**

Where,

A = Maximum value of civil engineering works executed in any one year during the last five years (updated to the price level of the last year at the rate of 10 percent a year) taking into account the completed as well as works in progress.

N = Number of years prescribed for completion of the works for which bids are invited (period up to 6 months to be taken as half-year and more than 6 months as one year).

M = M is taken 2.0

B = Value, at the current price level, of existing commitments and on-going works to be completed during the next 1.5 years (period of completion of the works for which bids are invited).

The Bidder shall submit his self-calculated bid capacity as per the above formula on a prescribed format given in **Annexure-1**. He shall also submit details of his existing commitments and works for which bids already submitted as per the format given in **Annexure-2**.
